Organization Requirements—2018 Impact Grant Program

ELIGIBLE ORGANIZATIONS

- Any established 501(c) (3) public charity as defined under the Internal Revenue Code or governmental agency.
- The program must serve people in Dodge, Jefferson, Kenosha, Milwaukee, Ozaukee, Racine, Sheboygan, Walworth, Waukesha or Washington County.
- The program must primarily provide direct services to LGBTQ+ members of communities who reside in at least one of the above counties.
- Organization affirms that it is an Equal Opportunity Employer and complies with all laws and regulations
 prohibiting employment or other discrimination. Organization agrees not to discriminate against any
 employee, applicant for employment, customer, volunteer or any person eligible for services by their
 organization because of age, race, religion, color, handicap, sex, physical condition, developmental
 disability, gender identity and expression, sexual orientation or national origin.

APPLICATION REQUIREMENTS

- Organization must submit a complete entry and supply all information and forms as listed in the application.
- Organization may only apply for one grant. All completed applications will be considered. Each
 application is reviewed by a committee comprised of Cream City Foundation board members and
 community partners. A determination is made if it fits with the intent of the Cream City Foundation
 request for proposals in each of the identified areas of impact (equity, health, prosperity). Organizations
 will be notified.
- A minimum of two organizations must partner together on the proposed project; ideally one
 organization will provide LGBTQ+ cultural competency and the other organization(s) will provide
 competency in the direct service delivery in one of the elevated priority areas of equity, health or
 prosperity.

INELIGIBLE ORGANIZATIONS

- Organizations that hold a position against or advocate against the rights of LGBTQ+ members, or communities
- Scholarship funds
- Public and private foundations or Endowments and any nonprofit that redistributes funds to other organizations
- Individuals participating in contests or pageants or individual appeals for services
- Trips, tours or conferences
- Festivals or events Cream City Foundation will entertain sponsorship proposals outside of this grantmaking mechanism

Grant RFP—2018 Impact Grant Program

Using a theory of change grant-making model, Cream City Foundation has identified impact areas within each of the three elevated priorities.

Cream City Foundation invites applicants to seek funding for the 2018 Impact Grant in response to the discrimination and systemic oppression LGBTQ+ communities face.

These grants will provide organizations the opportunity to serve LGBTQ+ populations with services that address the most pressing needs. The purpose of each Impact Grant is to expand the number of organizations participating in this important work.

Applications will be reviewed by Cream City Foundation's board of directors and the Foundation's grants committee.

Applications will be evaluated on the following criteria:

- A minimum of two organizations must partner together on the proposed project; ideally one
 organization will provide LGBTQ+ cultural competency and the other organization(s) will provide
 competency in the direct service delivery in one of the elevated priority areas of equity, health or
 prosperity.
- Quality and relevancy of the proposed project as demonstrated through the application.
- Level of impact to LGBTQ+ people of the proposed project, with consideration given to programs specifically addressing the needs of communities of color, the trans community and rural communities.
- Strength of infrastructure for the partnership and project.
- Sustainability of the partnership (external funding, financially self-sustaining).

Applications should respond to one of the impact areas in the submission. Please read the descriptions below:

EQUITY: Creating opportunities to bridge our understanding that the LGBTQ+ community is not one monolithic community but one that is comprised of multiple communities with intersecting identities, experiences and oppressions.

The Foundation is entertaining proposals that will help build a welcoming and culturally-competent environment in these impact areas:

- 1.) Law enforcement and criminal justice system
- 2.) Education system, including schools/colleges/universities

HEALTH: Creating opportunities to pursue health and happiness. Addressing health issues to secure access to competent and welcoming health care providers, health insurance, physical and mental health treatment and care.

The Foundation is entertaining proposals that will help build a welcoming and culturally-competent environment in these impact areas:

- 1.) Health access; or, healthcare professional competency in LGBTQ+ care
- 2.) Emotional health; or, utilizing trauma-informed care within an LGBTQ+ communities

PROSPERITY: Creating opportunities to earn a living and provide for families and selves. Addressing economic justice issues to secure access to housing, food, education, and employment with fair and inclusive workplaces.

The Foundation is entertaining proposals that will provide greater access in these impact Areas:

- 1.) LGBTQ+ workforce development and/or job training
- 2.) LGBTQ+ access to safe, affordable housing

Submission Guidelines—2018 Impact Grant Program

Additional Qualifiers or Restrictions

- Only one (1) submission is allowed per organization per impact area (equity, health, prosperity). If
 organization is affiliated with other entities, only one submission from either the parent or its
 subsidiaries will be considered.
- All information submitted will become the property of Cream City Foundation and will not be returned.
- Incomplete entries may be disqualified.
- Cream City Foundation reserves the right to disqualify any organization it deems inappropriate for the program.
- Submissions received after the deadline will not be accepted.
- Cream City Foundation reserves all rights and all decisions are final.

- Describe specifically how Cream City Foundation Impact Grant dollars will be used.
